i) Application for Business License – Kylik Kisoun-Taylor (11.c.ii.)

Council discussed this application in length. Stated that there is a filming policy that he has to abide by, submit applications to EISC, TCC, and HTC to operate a tourism business in the area. The fact that we have many tourism operators in town, and some stipulations will have to be laid out for out-of-town operators, so as not to give 'free reign' of cultural lands to non-locals. Since Kylik states that he will be working with a local business it does work in his favour. Council proceeds by deferring this application until more information on tourism plan is submitted and necessary applications are issued from affiliated organizations.

ii) Letter from Caroline Wawzonek, Minister of Infrastructure re: Inuvik Tuktoyaktuk Highway Conditions (11.c.ii)

Deputy Mayor Tyrone Raddi reads letter to Council.

SAO Holly Campbell informs Council that she referred to the Public Highways Act to continue to push for a safe highway. It states in the act that there are certain things that they are responsible for, and there have been so many close calls on the highway.

Councillor Jackie Jacobson stated that our MLA sits at the table every day, and notes that she is not getting the support she needs to make things happen.

Deputy Mayor states that during May-June, the road will wash out and Infrastructure will have to spend millions in the end.

Councillor Maureen Gruben states that the conditions should be reported to the WSCC Board. If they drove on the highway, they would shut it down and she thinks that Council needs to make them aware.

Councillor Joe Nasogaluak stated that it is a matter of not only safety, but life. People are running into banks to avoid collisions and he states that it needs to be shut down until fixed.
